

**PROCEEDINGS OF MINUTES OF A REGULAR MEETING  
OF THE TOWN OF OAK GROVE, LOUISIANA  
TUESDAY, APRIL 10 2024 – 5:00 P.M.**

The Town Council of Oak Grove met in regular session on Tuesday, April 10, 2024 at 5:00 p.m. Present for the meeting were Council Members Nevels, Walker, Allen, Holland, and Phillips. Mayor Rollinson presided.

Invocation was led by Council Member Allen.

Council Member Holland made a motion, seconded by Council Member Allen to approve the minutes of the March 12, 2024 meeting. The motion carried.

Council Member Nevels made a motion, seconded by Council Member Allen to approve adding the following items as new business: (A) consider application for a new sign at the radio station. The motion carried.

Council Member Nevels made a motion, seconded by Council Member Phillips to approve the March 2024 financials and bills for payment. The motion carried.

Council Member Nevels made a motion, seconded by Council Member Allen to adopt an Ordinance prohibiting urinating in public. The motion passed unanimously. The Ordinance is recorded in Ordinance Book No. 4; page 22; as Ordinance No. 622.

Council Member Holland made a motion, seconded by Council Member Phillips to table the proposal for the National Register Historic District Resurvey and Update until the May meeting to allow time to get a list of property owners that would be interested. The motion carried.

Council Member Nevel made a motion, seconded by Council Member Walker to appoint Jessie Craft as Fire District Board Member for two years and Mike Cox as Fire District Board Member for one year. The motion carried.

Council Member Allen made a motion, seconded by Council Member Phillips to approve a quote from Fisher Stump Grinding in the amount of \$800 to grind two stumps in the park. The motion carried.

Council Member Holland made a motion, seconded by Council Member Phillips to approve a quote from Shannon Ainsworth to repair the shower in the police department for \$1,500.00. The motion carried.

Council Member Nevels made a motion, seconded by Council Member Phillips, to approve a quote from Shannon Ainsworth in the amount of \$3,850.00 to re-pipe the gas at the Legion Hut and repair a leak. The motion carried.

Council Member Holland made a motion, seconded by Council Member Allen to approve a policy for police overtime pay. The motion carried.

Chief Russell gave his monthly report.

Council Member Nevels made a motion, seconded by Council Member Phillips to approve a new sign for Mix 96 FM to be painted over the existing sign at 230 East Main Street. The motion carried.

Council Member Allen made a motion, seconded by Council Member Holland to adjourn at 5:27 p.m. The motion carried.
